21/0998 the following comments were agreed upon in relation to this planning application.

- BPC disheartened the application was granted permission in the first place due to RBC not having its Local Plan in place.
- The development is outside the Parish Boundary.
- There was and still is no demand for housing in the village.
- No amenities in the village and all residents who live on this development will require
 a car to access larger villages for provisions; this is not helpful in relation to climate
 controls.
- The Parish Council still of the opinion this development and the entrance to it is too close to the junction with the Stockton Road and they consider it to be unsafe.
- If RBC are mindful to approve the application, can there be a clause in the permission which states all development traffic, whether that be workers or delivery vehicles, are to be parked on the site itself for the entire period of the build to ensure the junction with Stockton Road is not blocked in any way shape or form and verges around the site and junction are not damaged.
- Residents will also appreciate the vehicles being kept on the site.
